1. Restricted to a warehouse business, involving the storage of frozen meat, poultry and fish foodstuffs only.
2. All products to be obtained from approved/registered sources only.
3. No manufacture, preparation or sale of prepared foodstuffs to be undertaken on the premises.
4. The owner undertaking immediate remedial measures should a noise/smoke/odour nuisance arise.
5. Smoking is prohibited on the premises as a designated smoking area has not been provided.
6. Foodstuffs liable to decomposition or deterioration at ordinary/ ambient temperatures must be stored/or displayed either at the temperature of not more than 5°C or less than 60°C as the case may be.
7. All foodstuffs for sale must be labelled in terms of the Foodstuffs, Cosmetics and Disinfectants Act No.54 of 1972.
8. No playing of any live music or karaoke or any amplified music that may cause a disturbance to the neighbourhood.
9. The premises must be kept free of flies, cockroaches, rodents and any other pests.
10. The premises including the refuse bins must be maintained in a neat, clean and tidy condition at all times.
11. This Department reserves the right to call for additional health requirements, should the need arise.
12. This certificate is valid only for the premises as stated above and is not transferable to any other premises.
13. This certificate may be withdrawn verbally or in writing by the Head: Health and be repealed should it be found that the premises do not comply with the relevant bylaws or regulations, or any other condition which in the opinion of the Head: Health could be detrimental to the public health.
14. The issue of this certificate does not exempt the management of the business from compliance with any other bylaw, regulation or restriction relevant to any relevant authority.
